



2017 Vendor Registration

Dear Booth Operator:

This letter contains a two-step booth application form for the 2017 Fermentation Celebration. Please note booth rental fees are listed on the application on page 3.

This year's festival begins on Saturday, June 24th 2017 and will run through 11pm. Official booth days and schedules are as follows:

- Saturday 8am to 12:30pm – Booth setup
- Saturday 1pm to 11pm – Booths open to public

Here are some simple tips to help us help you.

1. Print and fully complete application (page 3) and return promptly no later than May 20th, 2017.
2. Include ALL applicable contact information.
3. If your booth is a trailer, please indicate so we can schedule your setup time properly.
4. Read ALL booth rules and sign and return page 4 as shown. Failure to do so will invalidate your application.
5. Include a certificate of insurance naming Old Vernon Liquors as a certificate holder.
6. Include full payment with application.

This festival is hosted by Old Vernon Liquors and staffed by volunteers that want to make your stay with us as convenient as possible. Please abide by the following rules during your stay.

1. Report to the registration booth to check in immediately upon your arrival before you begin setup.
2. Old Vernon Liquors and Muscatatuck Park do not supply tables (unless requested), chairs, coverings, extension cords, canopies, etc. nor do they help with the setup or tear down of any booth.
3. No water or electric will be provided. Small generators are permitted and must be provided by the vendor.
4. If your booth is a trailer and the total length (including tongue) exceeds a 10'x20' booth space, then please note that on this application.
5. Each vendor will be allowed to park two vehicles free of charge.
6. No pets of any kind (except service animals) are allowed on festival grounds at any time for sanitary reasons.



7. Disposing of grease with wastewater is prohibited.
8. The following items are not allowed to be sold: foul smelling novelties, items that can be used as drug paraphernalia, knives that are considered illegal (spring loaded, double edged, excessive length, etc.). The selling of these items will result in the immediate dismantle of your booth without refund of any kind and may result in arrest.
9. All booth spaces are available on a first come, first serve basis. In order to reserve booth space(s), the full amount of booth fee must accompany a completed application. No exceptions.
10. No political booths will be allowed at the festival.
11. No exotic animal booths will be allowed at the festival.
12. There will be a \$40 charge for any returned checks.
13. There will not be any refunds for any reason including weather conditions. Absolutely no exceptions will be made.
14. Old Vernon Liquors/Fermentation Celebration, and Muscatatuck Park are not responsible for any duplication in the type of craft items which might be sold in the different booths.
15. No vehicles are allowed in the tasting/festival area during festival hours. Setup or tear down during festival hours can continue by carrying your projects in and out of the parking area. Setup will not be allowed to start before 2 pm on Friday (Friday setup is an exception for vendors camping all weekend – contact us for details).
16. Old Vernon Liquors and their volunteers, employees and/or their agents and/or Muscatatuck Park and their volunteers, employees and/or their agents will not be held responsible for lost or stolen property.
17. Old Vernon Liquors and their volunteers, employees and/or their agents and/or Muscatatuck Park and their volunteers, employees and/or their agents will not be held responsible for injuries or damage done to your property.
18. Absolutely NO outside alcohol permitted in the event area. Do not attempt to bring any alcoholic beverages into the festival area that you will be vending at.
19. All persons vending must be 21 or older.
20. Old Vernon Liquors/Fermentation Celebration reserves the right to refuse service to anyone at any time.
